The undersigned (hereinafter "mare owner") Owner of the mare _____

Registration NO. _____ agrees to breed the mare to Sir Lancelot
A pure bred Friesian, standing at Blue Moon Hills in Drummond WI.

The mare owner agrees to pay a breeding fee of \$600. Covering the 2008 season to the
Owner of the stallion according to the following schedule:

1. Booking fee of \$50. Balance of \$550. To be paid when the mare arrives at Blue Moon Hills. Booking fee is non-refundable.
2. In addition, Mare owner agrees to pay Blue Moon Hills the following expenses, which will be billed on a monthly basis:
 - A. Board to be calculated at the rate of \$7.00 per day. (out side stall) \$9.00 per day (in side stall), \$9.50 per day mare and foal.
 - B. Veterinarian fees including drugs, medications, supplies and sales taxes.
 - C. Ferrier fees.
 - D. All other expenses reasonable and necessary to insure the well being of the mare.
3. Prior to or at the time of arrival of the mare, Mare owner shall certify to Blue Moon Hills on Mare owner's information form;
 - A. That the mare has received a negative cog gins test within the past six months. A copy of which must be supplied.
 - B. That the mare has been inoculated against tetanus infection within the past six months.
 - C. That the mare has had flu-vaccine within the past six months.
 - D.

If evidence of the above is not present upon delivery of the mare, Blue Moon Hills will have these items performed at the Mare Owners expense

4. The Mare Owner consents to such cultures and laboratory work as deemed necessary by the veterinarian selected by Blue Moon Hills and agrees to pay the reasonable cost of the same.

5. Blue Moon Hills reserves the right to refuse acceptance of the mare under this agreement if, in its sole judgment, it deems a foal which will compliment both the stallion and the mare.

6. The Mare must be trained so that she can lead and be tied with a halter. She must also be safe to work around her back feet.

In addition, in the event that major medical problems arise or develop, which in the opinion of Blue Moon Hills would preclude the breeding of said mare, upon notification of mare owner, this agreement shall terminate and the parties shall be relieved of any further obligation or liability hereunder except for the Mare Owner's obligation to remove the mare from Blue Moon Hills at his expense and to pay all outstanding bills for services rendered.

7. Mare Owner agrees that under no circumstances will such owner(s) or owners representative, hold Blue Moon Hills (Reg and/or Mary Behrends), employees, Farrier, or veterinarian responsible for injury, death, loss or damages of any kind that may occur to horse(s), individuals, or equipment while at Blue Moon Hills or thereafter.

8. Total balance of all expenses incurred are payable before departure from Blue Moon Hills.

9. Blue Moon Hills guarantees a live foal from this mating. A live foal is defined for the purpose hereof as one which stands and nurses. Should the mare abort at an time after her departure from Blue Moon Hills, or should her foal be born dead:

- A. Blue Moon Hills guarantees the rebreeding of said mare during the same season or
- B. A return breeding for \$ the cost of mare care during the following season, providing the stallion is available and able to service mares. Otherwise, another stallion owned by Blue Moon Hills may be substituted.

This guarantees shall not apply unless:

C. Blue Moon Hills is notified by letter or telephone within ten (10) days of delivery of the aborting or the foals death.

D, A statement from a licensed veterinarian must follow within fourteen days of the death, setting forth the details thereof and certifying that such abortion or death did occur.

Should the Mare Owner fail to execute new breeding contracts and deliver the mare for rebreeding within that breeding season or the next breeding season should the delivery of the dead foal or abortion occur out of the season set forth in this contract, any and all fees paid shall not be refunded and this contract is hereby terminated.

In the event Blue Moon Hills does not have a breeding stallion available, the breeding fee paid will be refunded.

In the event the mare cannot be settled or continually aborts, another mare may be substituted with prior approval by Blue Moon Hills.

10. This contract, signed by the respective parties at the places and on the dates set forth below, constitutes the entire agreement between The parties and may not be amended or modified except by a mutual exchange of written instrument. This contract or any rights or obligations there under may not be assigned without prior written consent of both parties.

11. The terms and conditions of this agreement notwithstanding, if the Mare Owner violates any of the terms and provisions of this agreement, the guaranty set forth in paragraph 9 shall immediately be null and void and Blue Moon Hills obligation there under shall be terminated.
